Dec. 14, 9 am: NW region meeting, Tallahassee Junior Museum. Dr. Hamid Garmestani of the FSU-FAMU College of Engineering will make a lecture presentation. Dr. Garmestani is a young and very cordial professor and researcher in mechanical engineering, with a specialty in composite materials (i.e., combining metals and ceramic fibers). Dr. Garmestani will give a general talk on ferrous metals and other subjects of interest to blacksmiths, and will endeavor to answer member questions on anything dealing with metal properties and behavior. BLACKSMITH MAGIC

Many African tribes consider blacksmiths to be just a little bit better than the average citizen. His hammer is supposedly endowed with all kinds of spiritual power. If he accidentally points the hammer at an individual, it is believed this person will die.

The only way to prevent this mishap is to kill a goat and cut two finger rings from the animal's skin. One must be worn by the smith on the middle finger of his right hand; the other donned by his inadvertent victim on his corresponding finger. 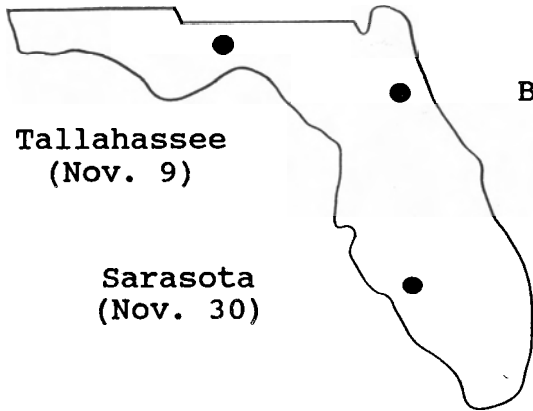
